Reason for change and expected benefits/business motivation:

The definition of the fields "Debit/Credit Code", "Currency" and "Settlement Amount" in the Data Migration Tool (DMT) is not correct as it allows creating Settlement Instructions with inconsistent data not in line with A2A and U2A specifications.

The inconsistency relates to (typically) Against Payment fields when they are used for information in Free of payment instructions (i.e. FOP instruction informing about cash payment to be performed outside T2S).

Provided that the DMT allows Users to send to T2S Settlement Instructions with inconsistent information as regards the against payment attributes mentioned above, T2S cannot create the subsequent status message notifications due to an ISO message schema validation error.

In order to solve this problem, the DMT specifications should be aligned with the relevant A2A (sese.023 ISO message) and U2A (Settlement Instruction New screen) specifications.

Description of requested change:

Data Migration Tool and its related documentation should be updated to include the relevant specifications to align the Cash Payment related fields of a Settlement instruction with the A2A/U2A specifications.

Proposed wording for the Change request:

The DMT File format specifications section 3.1.3.3 should be updated as follows:
