

SSP RELEASE 12.1: CONFIRMATION OF THE START OF ACCEPTANCE TESTING AND BUG FIX

The Eurosystem confirm the forthcoming installation of the TARGET2 SSP release 12.1 in CUST planned for the 8th March 2019 after close of business and the start of the Acceptance testing phase by Central Banks from the following Monday 11 March. As mentioned already in a previous <u>communication</u>, the first 2 weeks (11 till 21 March¹) will be dedicated to regression testing in relation to the implementation of the CR-788 (T2SI) configured in <u>dormant</u> mode. The following 2 weeks (25 March - 5 April), Central Banks will continue the acceptance testing with the CR-788 configured in <u>active</u> mode. Afterwards the User testing phase will start from the 8 April and finish on the 18 April 2019.

This intermediary TARGET2 SSP release 12.1 is also a bug fix release. The <u>provisional bug fix list</u> published on the same TARGET2 web site on 25 January 2019 has been revised² and the release will comprise the following bug fixes:
