

## **TARGET2 SSP RELEASE 12.0: CONFIRMATION OF GO-LIVE**

With this communication the Eurosystem confirms the go-live of this release on 19 November 2018 as planned. In addition, the status of previously communicated bugs as well as the status of newly detected bugs is provided in this report.

In the previous communication dated 3 November 2018 the Eurosystem could not yet report on the acceptance testing related to end-of-day balances on TIPS dedicated cash accounts in the adaptation of Reserve Management and Standing Facilities modules. The Eurosystem now confirms that these testing activities have been completed successfully.

The following table shows the status of bug fixes affecting the participants, as announced in the communication published on 29 May 2018:
