Description of requested change:

Solution 1:

The TIPS directory should include a maximum amount for each Authorised Account User in TIPS (User BIC). The default value is the maximum amount defined by the SCT Inst scheme rulebook. Other values could be an unlimited amount or any other amount above the SCT Inst scheme rulebook defined maximum amount.

When the EPC decides to change the maximum amount, then all values must be checked whether they are below the new maximum amount. For those Authorised Account Users in TIPS (User BICs) their value will be changed into the new maximum amount.

Solution 2:

The TIPS directory should include a flag for each Authorised Account User in TIPS (User BIC) which indicates whether they only want to accept instant payments with amount up to the maximum amount or they also accept any amount above the maximum. This is in line with EBA Clearing's approach for RT1.

When the EPC decides to change the maximum amount, then there is no need to check the directory.

For both solutions, it is valid that TIPS does not need to validate on the amounts defined in the TIPS directory.

Reason for change and expected benefits/business motivation:

The beneficiary bank may refuse a SCT Inst transaction exceeding the maximum amount for instructions under the SCT Inst scheme rulebook. This maximum amount is today 15,000 euro. For an originator bank, it is unclear, before sending the transaction, whether a beneficiary bank is willing to accept a SCT Inst transaction exceeding the SCT Inst maximum amount and, if so, up to which amount.

The business need is that the originator bank can inform its customers upfront, before submitting the SCT Inst transaction, whether it can actually be processed as an instant payment. This helps to avoid a negative customer experience as every rejected payment is perceived as such.

Proposed wording update to the documentation to address the requested change:

The two proposed options will be assessed separately in terms of scope and cost assessment.

However, for both options the assumption is that no impacts will materialise on the current TIPS processing stemming from this Change Request.

Therefore, this implies that the 'Maximum Amount' parameter value shall remain set to 'unlimited'. If this assumption is not fulfilled, an additional change would materialise in TIPS, regarding the removal of Business Rule 010005 – "Maximum Amount not exceeded", whose impact will have to be assessed via a separate Change Request.

The maximum amount defined in the EPC SCT Inst scheme rulebook shall be captured in CRDM into a system parameter (e.g. *DEFAULT_MAX_AMOUNT_EPC*). The new parameter shall be initialised to 15,000.00 EUR and used as a default value when configuring the Authorised Account User entity.

Any subsequent update of such a system parameter made by the Operator, stemming from an update from the EPC Rulebook, shall trigger a revalidation of the content of the existing Max Amount fields captured into the Authorised Account User entity. In particular for each User BIC:

- if the 'Max Amount' field is below the new maximum amount, their value shall be replaced by the new maximum amount;
- if the 'Max Amount' field is above or equal to the new maximum amount, their value shall remain unchanged.

Summary of functional, operational, development, infrastructure and security impacts

Summary of functional impact:

Option 1:

- Definition of a new attribute at Authorised Account User level whose value represents the maximum amount acceptable by the User BIC for incoming Instant Payments. Besides any numeric value greater than the EPC maximum amount default value, it shall be possible to capture also the following additional special values: zero, unlimited.
- 2. The CRDM Back-end and the CRDM GUI have to be aligned accordingly.
- 3. A new system parameter shall be captured in CRDM and initialised to the EPC SCT Inst scheme maximum amount.
- 4. A new functionality shall detect any further changes made by the Operator to the above-mentioned system parameter and trigger the revalidation of the content of the new AAU field 'Max Amount'.
- 5. The assumption is that migration of reference data is required. This implies that the new attribute Max_Amount in the AAU will be initialised to the default maximum amount when this CR is deployed. Afterwards each party shall adapt the configuration autonomously,

Option 2;

- Definition of a new flag at Authorised Account User level whose value identifies whether any amount above the EPC SCT Inst scheme maximum value is acceptable or not by the User BIC for incoming Instant Payments.
- 2. The CRDM Back-end and the CRDM GUI have to be aligned accordingly.
- 3. The assumption is that migration of reference data is required. This implies that the new flag Accepted_Amount in the AAU will be initialised to the default maximum amount when this CR is deployed. Afterwards each party shall adapt the configuration autonomously.

Summary of operational impact:

No operational impact.

Summary of application development impact:

The TIPS Directory is a report that is (a) produced by CRDM, (b) delivered from CRDM to TIPS, (c) sent from TIPS to participants.

Both options have only impact in phase (a) above. No impacts are foreseen in TIPS application.

CRDM components impacted by both options are:



- CRDM GUI, to allow participants to browse or update the amount (option1) or the flag (option2)
- CRDM Back-end, to make data changes in the database
- CRDM Back-end, to adapt database (AAU entity) to include new data (either amount or flag)
- CRDM Back-end, to include new data (either amount or flag) into the TIPS Directory
- CRDM Data Migration Tool, to allow new data to be entered massively into CRDM database

Additional CRDM components impacted only by option1 are:

- CRDM GUI to allow Operator to browse or update the EPC SCT Inst scheme maximum amount (it is assumed that the first creation of entry per currency will be performed manually, using last-level rights)
- CRDM Back-end to update database table Currency/Service Link, CSL (it is assumed that the first creation of entry per currency will be performed manually, using last-level rights)
- CRDM Back-end, to adapt database (CSL entity) to include EPC scheme maximum amount
- New function to update all AAU relevant entries in case of increase of the EPC scheme maximum amount.
