
Euro Area Securities Issues Statistics: October 2016

- The annual rate of change of the <u>outstanding amount of debt securities</u> issued by euro area residents decreased from 0.0% in September 2016 to -0.3% in October.
- For the <u>outstanding amount of listed shares</u> issued by euro area residents, the annual growth rate was 0.9% in October 2016, the same as in September.
- The annual growth rate of outstanding <u>debt securities issued by non-financial corporations</u> increased from 5.5% in September 2016 to 6.3% in October.

Debt securities

<u>New issuance</u> of debt securities by euro area residents totalled EUR 549.2 billion in October 2016. <u>Redemptions</u> stood at EUR 560.2 billion and <u>net redemptions</u> amounted to EUR 6.7 billion. The annual rate of change of <u>outstanding debt securities</u> issued by euro area residents decreased from 0.0% in September 2016 to -0.3% in October.

As a full breakdown of net issues into gross issues and redemptions is not available due to missing data, the difference between aggregated gross issues and redemptions may deviate from the aggregated net issues.

Euro Area Securities Issues Statistics: October 2016

Breakdown by maturity

The annual rate of change of outstanding <u>short-term debt securities</u> decreased from -1.3% in September 2016 to -2.2% in October. For <u>long-term debt securities</u>, the annual rate of change was -0.1% in October 2016, compared with 0.1% in September. The annual growth rate of outstanding <u>fixed rate long-term debt securities</u> was 2.3% in October 2016, compared with 2.5% in September. The annual rate of change of outstanding <u>variable rate long-term debt securities</u> was -9.0% in October 2016, compared with -9.2% in September.

Breakdown by sector

As regards the sectoral breakdown, the annual growth rate of outstanding <u>debt securities</u> issued by <u>non-financial corporations</u> increased from 5.5% in September 2016 to 6.3% in October. For the <u>monetary financial institutions (MFIs)</u> sector, this rate of change was -4.0% in October 2016, compared with -3.9% in September. The annual rate of change of outstanding debt securities issued by <u>financial corporations other than MFIs</u> decreased from -0.8% in September 2016 to -1.3% in October. For the <u>general government</u>, this growth rate decreased from 1.7% in September 2016 to 1.4% in October.

The annual growth rate of outstanding <u>short-term debt securities issued by MFIs</u> decreased from 2.7% in September 2016 to 0.8% in October. The annual rate of change of outstanding <u>long-term debt securities</u> <u>issued by MFIs</u> was -4.7% in October 2016, compared with -4.8% in September.

Breakdown by currency

Concerning the currency breakdown, the annual rate of change of outstanding <u>euro-denominated debt</u> <u>securities</u> was -0.3% in October 2016, the same as in September. For <u>debt securities in other currencies</u>, this rate of change decreased from 1.2% in September 2016 to -0.3% in October.

Listed shares

New issuance of listed shares by euro area residents totalled EUR 8.0 billion in October 2016. Redemptions came to EUR 0.9 billion and net issues amounted to EUR 7.1 billion. The annual growth rate of the outstanding amount of listed shares issued by euro area residents (excluding valuation changes) was 0.9% in October 2016, the same as in September. The annual growth rate of listed shares issued by non-financial corporations was 0.7% in October 2016, compared with 0.6% in September. For MFIs, the corresponding growth rate was 2.8% in October 2016, the same as in September. For financial corporations other than MFIs, this growth rate decreased from 1.7% in September 2016 to 1.4% in October.

The market value of the <u>outstanding amount of listed shares</u> issued by euro area residents totalled EUR 6,665.8 billion at the end of October 2016. Compared with EUR 6,832.0 billion at the end of October 2015, this represents an annual change of -2.4% in the value of the stock of listed shares in October 2016, down from 4.8% in September.

- Unless otherwise indicated, data relate to non-seasonally adjusted statistics. In addition to the developments for October 2016, this press release incorporates minor revisions to the data for previous periods. The annual growth rates are based on financial transactions that occur when an institutional unit incurs or redeems liabilities, they are not affected by the impact of any other changes which do not arise from transactions.
